**INFORMATION ABOUT SELECTION OF THE MOST ADVANTAGEOUS OFFER**

Concerning proceedings for the award of a public contract, conducted in the form of a request for quotation, the subject of which is the service consisting in the purchase of access to the market database for the purposes of the project Innovation Incubator 4.0 (Contract in question No. MNISW/2020/334/DIR of 28.09.2020).

The Contracting Authority announces the selection of the most advantageous offer submitted by:

**Global Data UK LTD, John Carpenter House, John Carpenter Street, London, UK, EC4Y0AN.**

**Rejected bids:**

The contracting authority rejected the bid of MarketsandMarkets Research Pvt. Ltd due to failure to meet the formal condition for participation in the proceedings.

**Justification:**

In Information No. 1 for Contractors dated 28th of August 2023 published in the Competitive Database on 30th of August 2023 (5 days before the deadline for submission of bids and sent to Contractors via email on 30th of August 2023), the Contracting Authority amended III.2) CONDITIONS FOR PARTICIPATION III.2.1.) in item 2 of Request for Proposal 2023-47155-155176 with the following wording: The Contractor shall demonstrate that in the last 5 years before the deadline for submission of tenders, and if the period of activity is shorter - in this period, he has performed or is performing at least 3 services consisting in the supply of market databases, in particular to universities and scientific units, and shall attach evidence indicating whether these services have been performed or are performed properly (Annex No.4).

On 14th of September 2023, the Contractor was called for supplements based on the letter dated 14th of September 2023, in which the Contracting Authority informs in point 4 of this letter that it is necessary to provide evidence of due performance of these services. In response, the Contractor provided only a list of services performed (Annex No. 4) without attaching evidence of their due performance. Thus, the bid is subject to rejection.

The contracting authority shall announce the names or forenames and seats or places of business or residence of the contractors whose bids have been submitted and the scores awarded for each bid evaluation criterion and their total scores:
