The project is made in the framework of SPINAKER Program - Intensive International Education Programs.

## II. Procedure to be followed

An order with value below PLN 130 000 net, awarded in the form of a request for quotation, in connection with Art. 2 section 1 point 1 of the Public Procurement Law.

## **III. Subject of the contract**

## **Description of subject of the contract:**

The subject of the contract is the preparation and conducting of classes under three Intensive International Education Programs (IIEP) for foreign students studying veterinary medicine at the Wroclaw University of Environmental and Life Sciences and veterinary students studying at foreign universities. Classes are to be conducted in English by foreign academic teachers.

## **Detailed description:**

The subject of the contract is:

- a. preparation of online lectures presentation (17 teaching hours) in English, in accordance with the Intensive International Education Program (IIEP) developed by a UPWr scientist in the field of diagnostics and treatment of the following animal species:
- horses,
- farm animals,
- small animals (cats, dogs),
- b. conducting classes in English in the form of online lectures (17 didactic hours) and a practical workshops (8 didactic hours) for foreign students of the last clinical years of veterinary studies, studying at the Wroclaw University of Environmental and Life Sciences, as part of the English Division, Erasmus + / CEEPUS Program, and at other foreign universities, taking into account the specific needs of students with disabilities, in particular visually impaired, hearing impaired students and students with attention deficit disorders, in accordance with the Guidelines for the implementation of the principle of equal opportunities and non-discrimination, including accessibility for people with disabilities and the principle of equal opportunities for women and men under EU funds for 2014-2020 (<u>https://www.funduszeeuropejskie.gov.pl/strony/o</u>

The participation of foreign students of veterinary medicine, studying at the Wroclaw University of Environmental and Life Sciences and foreign universities, in online lectures and practical workshops as part of one of the three Intensive International Education Programs (IIEP) is aimed at acquiring and improving the specialist clinical knowledge of students and increasing their clinical skills in the field of diagnosis and treatment of selected animal species.

The total number of classes in each of the three IIEP is 50 teaching hours. Out of the total number of 50 hours of IIEP, 34 teaching hours will be carried out in the form of online lectures, in the form of four 7-hour lectures and one 6-hour lecture (from Monday to Friday). The remaining 16 hours will be carried out in the form of two 8-hour practical workshops using medical equipment and live animals.

Online lectures and practical workshops will be conducted in English. Presentations for lectures and teaching materials for the practical workshops should be prepared in English.

The classes are aimed at groups of 90 foreign students of the last clinical years of veterinary medicine. This group will include 60 students studying at the Wroclaw University of Environmental and Life Sciences as part of the English Division (ED) and the Erasmus + / CEEPUS program, and 30 students from foreign universities providing education in the field of veterinary medicine.

The online lectures will be open, i.e. they will also be made available to Polish students studying at the Wroclaw University of Environmental and Life Sciences in the field of veterinary medicine, who are not Project Participants.

The subject of the contract will be carried out in the period no earlier than 01/05/2022 to 31/08/2023.

The detailed deadline for the implementation of online lectures and practical workshops within the IIEP will be agreed with the Contractors. At the same time, due to the current pandemic situation, the Ordering Party reserves the right to change the schedule in consultation with the Contractors.

For the purposes of conducting the practical 2-day part of the IIEP (practical workshop), the Ordering Party provides rooms in buildings belonging to the Wroclaw University of Environmental and Life Sciences, meeting the health and safety requirements and adapted to the needs of conducting practical workshops, including for people with disabilities.

The Ordering Party will cover the costs of travel, accommodation (planned for 7 days, hotel with breakfast) and meals for foreign lecturers up to PLN 4,920.00.

The Ordering Party also covers the costs of protective clothing and disinfectants as well as consumables used during clinical procedures (costs of drugs for sedation of animals, catheters, intravenous catheters, ultrasound gel, ECG electrodes).

- 1. preparation of the presentation for online lectures in English, in accordance with the Intensive International Program of Education in the field of diagnostics and treatment of selected animal species, developed by a UPWr scientist. - conducting of online lectures and practical workshops in English on set dates, taking into account the specific needs of people with disabilities, in particular visually impaired, hearing impaired and with attention deficit disorder, in accordance with the Guidelines on the implementation of the principle of equal opportunities and non-discrimination, including accessibility for people with disabilities and the principle of equal opportunities for women and men under EU funds for 2014-2020 (<u>https://www.funduszeeuropejskie.gov.pl/strony/ofunduszach/dokumenty/wytyczne-w-zakresie-realizacji-zasady-rownosci-szans-iniedyskryminacji-oraz-zasady-rownosci-szans/</u>).
- 3. verification of students' participation in the IIEP practical workshops by enforcing the signing of the attendance lists by practical workshop participants and providing the originals of the above-mentioned an attendance letter to the project office (Center for Student Affairs, Wroclaw University of Environmental and Life Sciences, M. Skłodowska-Curie 42, Wroclaw, room 2) within 2 working days from the date of the classes covered by the list,
- 4. preparation of documentation (tests, attendance lists, certificates confirming the completion of the course, lists confirming the receipt of certificates by participants) in the colour version and appropriate labelling of the above-mentioned documentation, in accordance with the applicable markings provided to the Contractor by the Ordering Party. The contractor is also obliged to provide each document with the following information:

- have the status of an academic teacher or teaching experience, obtained through at least 2 years of work as an academic teacher in the past (didactic / scientific / research),
- 2. have an European or American Veterinary Specialist (European / American Veterinary Specialist) **Diplomate** statute, in the scope of:
  - a) horse diseases:
    - European College of Equine Internal Medicine (ECEIM),
    - European College of Veterinary Surgeons (ECVS),
    - European College of Veterinary Diagnostic Imaging (ECVDI),
    - European College of Animal Reproduction (ECAR),
  - b) farm animals diseases:
    - European College of Bovine Health Management (ECBHM),
    - European College of Porcine Health Management (ECPHM),
    - European College of Small Ruminant Health Management (ECSRHM),
    - European College of Animal Reproduction (ECAR),

c) companion animals diseases - dogs, cats:

## VIII. Criteria for evaluating offers

- 1. The contracting authority will evaluate and compare the offers and select the most advantageous offer based on the following criteria:
  - the amount of remuneration (EURO gross/PLN gross<sup>1</sup>) for the online lectures and practical workshops for a total of 25 teaching hours (provided by the Contractor in Annex 1 - Request for proposal),
  - experience the total number of years of teaching experience in the field in which the classes will be conducted (Annex 2 Request for proposal).
- 2. The Contracting authority assigned the following meaning to the above criteria:

The offer with the highest number of points will be considered the best offer. An offer can be awarded a maximum of 100 points.

The contracting authority will calculate the points numerically to two decimal places, rounding off in accordance with mathematical rules.

The contracting authority reserves the right to negotiate the gross amount of remuneration with the Contractor who submits the most advantageous offer, if the value of the offer exceeds the amount of funds allocated to the service.
