Original and review papers presented at Student Research Circle's meetings are scored up to a maximum of 40 points. The papers that were presented at the Student Research Circle's meetings in order to practice presenting them at a later competition or conference should not be included twice in the reports.

If the paper was presented (or printed) at several national events, points are awarded as for presentation at the highest ranked event and 2 points are added for each presentation (or printing) of the paper at a lower ranked event. Points for presenting a paper at an event abroad are counted separately from presentations at conferences in the country. Papers co-authored by (apart from students - members of the Student Research Circle) researchers or PhD students will be evaluated in the same way as works written exclusively by students.

To be awarded points it is necessary to:

- attach a written paper in any form (at least the abstract of the work),

- attach the statement of the academic supervisor of the Student Research Circle on whether the paper is a review or is based on the authors' own work (template at the end of the "Criteria...").

- attach the academic supervisor's statement confirming that the presented work does not constitute (in part or in whole) a diploma or other thesis, resulting from the authors'



1. The deadline for submitting the documentation is 15 December 20....

- 2. The participation of the Adviser of the Student Research Circle is obligatory whenassessing the Student Research Circle operating in the department to which the organisational unit at which the Student Research Circle operates is assigned. When assessing the Student Research Circles operating in the area of more than one field of study, the advisers from all departments relevant to the Student Research Circle are involved.
- 3. In the case of a multi-section Student Research Circle's assessment, the sections are treated as independent units and assessed separately. Points obtained by individual sections are not added up.
- 4. Due to the specific nature of the Student Research Circle's activity in various disciplines, the assessment and classification of the Student Research Circle in a given discipline is made by the Commission. For comparative purposes, the Commission also makes an overall classification, but in the work report the results are presented separately for each discipline.
- 5. The Rector's Awards are granted to the best Student Research Circles of given departments.
- 6. At the meeting summarising the assessment of the activities of the Student Research Circle by the Commission, in order to present the results and distinguish the best-performing Student Research Circles, it is proposed to present reports submitted by the best Student Research Circles, their chronicles and other interesting materials resulting from their activities (videos, etc.).
